## **ALISHA 14 YEARS OLD MURDERED DROWNED IN THE SEINE ARGENTEUIL BY TWO OTHER PUPILS**

### **THE 2 SUSPECTS ARRESTED & FACE 20 YEARS**

She was murdered by two other students from her college who beat her and then threw her in the Seine, while she was still alive. Her killers had previously harassed her, One of the two student killer of the victim had ambushed her, making an appointment, then was beaten and then thrown into the Seine with the help of his girlfriend. The Public Prosecutor's Office is retaining the trail of « intentional homicide with premeditation", announced Eric Corbaux, The death of Alisha, described as a very good student, kind, and whose mother is upset by her loss and explains to journalists that her daughter had received death threats before the tragedy. Her tragic disappearance moved the whole of France with his monstrous death.

### **ALISHA AT 14 HAS BEEN HARASSED THEN PUNCHED AND DROWNED BY TWO OTHER STUDENTS FOR UNDERSTOOD REASONS-----**

The two teenagers responsible for the death of Alisha, 14, found dead in the Seine in Argenteuil, were indicted for murder on the evening of March 10. They were remanded in custody, according to BFMTV. They risk 20 years in prison and benefit from the excuse of minority. "The Public Prosecutor's Office is retaining the trail of « intentional homicide with premeditation", announced Eric Corbaux, public prosecutor of Pontoise, in front of the media, on March 10. Alisha, found dead on March 8 in Argenteuil, in the Val d'Oise, was struck, then thrown and drowned in the Seine, according to the first forensic evidence. The two college students as a couple, implicated in the death of the victim, were brought before an examining magistrate in Pontoise, after their custody. Alisha and one of the two college students were briefly in a relationship at the start of the year. After their breakup, the boy had started a new relationship with another college girl, the other teenager responsible for Alisha's death. ### **THE PLANNED CIRCUMSTANCES OF PREPARATION OF THEAMBUSH PURPOSELY TO KILL ALISHA-----**

The young girl friend of teenage killer Alisha, implicated in the murder, reportedly made an appointment with the victim on March 6, but the college girl was not available that day. Alisha would therefore have preferred to meet her on March 8, at Argenteuil station, without realizing that it was an ambush. All this enabled the Prosecutor to assert the notion of premeditation.The young girl would then have led Alisha to the level of Quai-Saint-Denis. Then, the young man, assailant, who was hiding "behind a pillar" would have attacked the victim and gave "blows by surprise".-----

Several "kicks and punches" to the back and head were reportedly dealt to Alisha while she was on the ground, but only by the young man. But previously, according to Alisha's parents, the victim, According to the parents of the deceased, Alisha was harassed, in particular by the two teenagers, in the high school where she was studying, the professional high school Cognacq-Jay d'Argenteuil.

And according to testimonies from students at France Bleu Paris, the deceased was being harassed, especially on social networks.  
THE SHOCKING REACTION OF THE TWO TEENAGERS KILLERS SAY HAVING NO REGRETS OVER THE MURDER OF VICTIM ALISHA-----

Alisha would have died by drowning according to the elements provided by the autopsy. The examination revealed "significant bruises on the skull, contusion to the eye and echymosis in the back". The victim was "conscious" and "moaning" before she was pushed into the water. The objective of the two pupils was to make the traces disappear, hence their initiative to throw the young girl into the Seine. After this sinister act, the teenage couple returned to the young boy's home to change their clothes and then left for lunch in Paris. "They did not express immediate remorse," added the public prosecutor.
